# TERMS AND CONDITIONS FOR FRINGE ACTIVITY REDEMPTIONS (18 AUGUST – 9 SEPTEMBER 2018)

- 1) The redemption is open to all Singaporeans and residents of Singapore only.
- 2) A single same day receipt (or a maximum of 2 combined same-day receipts) of \$30 entitles you to 1 stamp card. A maximum of 1 stamp card will be issued for all purchases regardless of the amount. Voucher redemption is limited to 1 set (\$20 worth of elemen vouchers) per shopper per day on a while stocks last basis.
- 3) Redemption of stamp cards and vouchers will be from 18 August 9 September 2018. Redemption of vouchers is limited to the first 300 shoppers only. Vouchers will be distributed on a first-come first-served basis and no reservation of vouchers will be entertained.

- 7) Shoppers are required to provide Name, NRIC, email address and mobile number to complete registration for redemptions from 18 August 9 September 2018. By participating, shoppers have given consent to provide contact details and to receive future communications from HarbourFront Centre.
- 8) Redemption is available from 10am to 9.30pm daily.
- 9) All vouchers must be taken as provided, is not transferable or exchangeable for cash or other form of prizes. The management reserves the right to replace/change the prize with one of equivalent value.
- 10) Information is correct at the time of print and the management reserves the right to amend the terms and conditions without prior notice.
