

TERMS AND CONDITIONS FOR HFC NATIONAL DAY COLOURING CONTEST 2017

 - (i) Singaporeans and residents of Singapore
(or one of the parent must be a Singaporean or resident of Singapore)
 - (ii) Between the age of 4 years old to 10 years old on the day of the Competition except employees of Mapletree Investments Pte Ltd, its advertising agencies, retail tenants of HarbourFront Centre and their immediate families.

Such Participants and/or their acts or omissions are the sole responsibility of the parent/legal guardian. Any default in this and/or absence of parent/legal guardian's expressed consent in Participants' participation shall lead to disqualification of the Participant.

2. Entries submitted by the Participant after the stipulated contest timing will not be considered and shall be deemed null and void. Participant may only submit one entry and participate in 1 session of the competition. Entry submitted will not be returned.

By participating in the Competition, the Participants hereby represent and warrant that the entries submitted by the Participants are original, not in breach of any third party rights and are not defamatory/offensive/hurtful to any person/sect/caste/religion etc. The entries should not be obscene, vulgar, denigrating to women, artists, celebrities, children and/or any other person, hurtful towards religious sentiments, depicting violence or against any public policy of Singapore. In the event of violation of the aforementioned, Participants shall be disqualified from the Competition with immediate effect and HFC reserves the right to reject the entries.
 4. By participating in the Competition, the Participant agrees to receive communication from HFC and its authorised representative.
 5. By submitting an entry to the Competition, Participants gives HFC:
 - (i) Permission for the entry to be published; and
 - (ii) The right to use Participant's name and age for the sole purpose of identifying Participant as the author of the entry.
- Entries will be judged on the Participants' colouring skill, originality and creativity etc. Decisions of the judges are final and binding.
