**TERMS AND CONDITIONS FOR
CHRISTMAS LUCKY DRAW 2017**

- 1) The Lucky Draw 24 November 2017 to 31 December 2017 is open to all Singaporeans and residents of Singapore except employees of Mapletree Investments Pte Ltd, its advertising agencies, retail tenants of HarbourFront Centre and their immediate families.
- 2) A single same day receipt (or a maximum of 2 combined same-day receipts) of \$50 purchase entitles you to a lucky draw chance. A maximum of 6 lucky draw chances will be issued for a single or a maximum of 2 combined same-day receipts of S\$300 and above.
