TERMS AND CONDITIONS FOR SPIN & WIN CONTEST

- 1) The redemption is open to all shoppers except retail tenants and employees of retail tenants.

Registration for ALL redemptions must be completed on the same day of purchase(s) at Level 1 Customer Service Counter. For all redemptions, only same-day receipts will be accepted and on a first-come first-served basis, and while stocks last.

- 2) Only **original** receipts from any retail shop/restaurant located in HarbourFront Centre are eligible. Receipts from **ferry/ coach operators, pushcarts, non- tenant atrium fairs, medical services and banquet deposit payments** are **NOT Eligible** for redemption or lucky draws promotions.
